DATA PROTECTION RESPONSIBILITY

AQUS GmbH and our affiliated companies that you deal with are in charge of protecting and handling your personal information as outlined in this policy.

WHAT THIS POLICY COVERS

We've created this Privacy Policy to explain how AQUS GmbH (along with our affiliated companies, subsidiaries, and related businesses) handles your personal information. This includes how we collect it, use it, share it, and protect it.

The way we handle your information depends on how you interact with us—whether you're browsing our websites, this website including its subpages as well as the ClearAmine®WebApp, the ClearAmine®Config App and other AQUS IT applications and services (further also called Site), buying our products, working with us as a business partner, or applying for a job.

BUSINESS CHANGES AND YOUR DATA
